Standard Fees

These are the fees that will apply if your child is not yet old enough to qualify for the nursery grant. Fees are very competitive and represent great value for money, they are inclusive of meals and all teaching and extracurricular activities such as music and dance.

Nursery School Fees

These are the fees that will apply if your child is old enough to qualify for the nursery grant ie. the term after the term they are 3 years old. Fees are inclusive of meals and all teaching, extracurricular activities such as music and dance and extended day care.

30 Hours Places

To qualify for nursery school fees, either the funded 15hrs or the new 30hrs, your child must be eligible for nursery grant. Your child will qualify in the term after the term in which they become 3 years old. Nursery grant can then be claimed for 2 years. Please also note that additional qualification rules apply to the 30 hours funding, see below.

30 Hours grant funded places are available from 1st September 2017 – please note that not all parents will qualify. You must go online to check your eligibility; if you are eligible you will get a code, which you will need to give us. You will also need to apply online, and re-apply every 3 months to qualify for and retain the additional grant. The nursery will not be liable for claims made incorrectly or too late and normal fees (15hrs grant) will be charged in these cases. These rules are set by the government and are strictly applied, we have no control over this but we will try and help you where we can.

Tax Free Childcare

Tax Free Childcare is a government scheme which is designed to assist families with their childcare. If you pay using Tax Free Childcare the government will pay 20% of the fees, saving you a large amount on your childcare. You can find out more about this at www.childcarechoices.gov.uk or come talk to us in the office and we can help you receive this funding.

Free Places

Normally, either; 3 (free 15 hours) or 6 sessions (free 30 hours), either am or pm, on separate days in term time only. You will be charged for lunch, snack and breakfast (£4.00pd) per am and Snack (£2.00pd) per pm. Places are subject to availability and days may be subject to change. Sessions may be added to the free place and these will be charged at standard nursery fees (see overleaf). Term dates are available on request or at <http://clarendoncottage-school.co.uk/> and go to term dates.

Note

Places may be combined but when combining nursery school fees only one of the places will qualify for grant. Please also note that all fees are subject to regular review - normally annually.
